1. Seller Information

2. Products and Availability

Saunística sells sauna-related products, accessories, and equipment to consumers and business customers.

All product descriptions, specifications, images, dimensions, and technical information are provided for informational purposes only. Minor differences in color, appearance, or technical details may occur.

Product availability may vary, and Saunística reserves the right to modify, discontinue, or limit products without prior notice.

3. Prices and Taxes

All prices displayed are shown in euros (EUR) unless otherwise stated.

For customers within the European Union, applicable VAT is included in the displayed price unless otherwise specified. For customers outside the European Union, local customs duties, import taxes, VAT, or other governmental charges may apply.

The customer is responsible for such charges unless otherwise explicitly stated.

Shipping costs are displayed separately before the order is confirmed.

Saunística reserves the right to change prices at any time before an order is placed.

4. Orders and Payment

Orders become binding once the customer has placed the order and payment has been successfully received.

Products are primarily paid for by invoice or by another payment method specified separately by the seller. Additional payment methods may be introduced later when Saunística's online store becomes fully operational.

Saunística reserves the right to refuse or cancel orders in cases involving pricing errors, suspected fraud, payment issues, product unavailability, or other justified reasons.

If an order is cancelled after payment has been received, the payment will be refunded to the customer.

5. Delivery and Shipping

Products are delivered to the delivery address provided by the customer.

Some products may be shipped directly from the manufacturer's warehouse.

Estimated delivery times are provided whenever possible but are not guaranteed unless expressly agreed otherwise in writing. Saunística is not responsible for delays caused by shipping carriers, customs procedures, force majeure events, supply chain disruptions, or other circumstances beyond reasonable control. The customer is responsible for ensuring that the delivery address and contact information provided are accurate. If a shipment is returned due to incorrect customer information or failure to receive the delivery, additional shipping charges may apply.

6. Transfer of Ownership and Risk

Ownership of the products passes to the customer once the products have been fully paid for and delivered.

The risk of loss or damage passes to the customer upon delivery of the products to the customer or to a person authorized by the customer to receive the delivery.

Saunística remains responsible for the products during transportation arranged by Saunística until delivery has been completed.

7. Inspection and Claims

The customer is encouraged to inspect the products upon delivery.

Any visible transport damage should be reported immediately to the carrier and, where possible, noted on the delivery receipt. If the customer notices defects, missing items, or other issues with the products, Saunística must be contacted within a reasonable time after discovery. This does not limit the customer's statutory rights under applicable consumer protection laws.

8. Right of Withdrawal and Returns

Consumers located within the European Union may have the right to withdraw from the purchase within fourteen (14) days from receiving the products, in accordance with applicable consumer protection legislation.

To exercise the right of withdrawal, the customer must notify Saunística in writing before the withdrawal period expires. Returned products must be unused, in substantially original condition, and returned with original packaging where reasonably possible.

The customer is responsible for return shipping costs unless otherwise required by law or agreed separately.

The right of withdrawal does not apply to customized or made-to-order products, products damaged due to customer misuse, or products otherwise excluded by applicable consumer legislation.

Refunds will be processed within a reasonable time after the returned products have been received and inspected.

9. Warranty and Defective Products

Products are covered by applicable statutory consumer protection rights and warranty obligations under Spanish and European Union law. If a product is defective, the customer may be entitled to repair, replacement, price reduction, or refund in accordance with applicable legislation. Normal wear and tear, improper installation, misuse, negligence, unauthorized modifications, or failure to follow product instructions are not covered.

Customers must follow all installation, safety, and operating instructions provided with the products.

10. Product Use and Safety

Products must only be used for their intended purpose and in accordance with all provided instructions, warnings, and local regulations. The customer is responsible for ensuring proper installation, operation, ventilation, fire safety, and compliance with local laws and regulations. Saunística is not responsible for damage caused by improper installation, incorrect use, unauthorized modifications, lack of maintenance, or use contrary to instructions.

11. Limitation of Liability

Nothing in these terms limits liability that cannot legally be excluded under applicable law.

To the maximum extent permitted by law, Saunística shall not be liable for indirect damages, consequential damages, loss of business, loss of profits, loss of use, or other indirect losses arising from the use or inability to use the products.

Saunística's liability is limited to the purchase price of the affected product unless otherwise required by mandatory law.

12. Force Majeure

Saunística is not responsible for delays or failure to perform obligations caused by events beyond reasonable control, including war, natural disasters, pandemics, governmental actions, strikes, transportation disruptions, supply chain interruptions, energy shortages, or other exceptional circumstances.

13. Privacy and Data Protection

14. Applicable Law and Dispute Resolution

If no agreement can be reached, disputes may be referred to the appropriate consumer dispute resolution authority or competent court in accordance with applicable law.

15. Governing Language

In case of discrepancies or inconsistencies between translations, the English version shall prevail.
